Given the proliferation of Lyme disease throughout the United States with over 300,000 new cases annually, many of whom have gone undiagnosed for years, increasing Federal research funding for Lyme and other tickborne diseases is important to develop better diagnostics and cures. As our military invests millions of American taxpayer dollars in the next warfighters on land, sea and air, we need to not only ensure their health and safety from this dreaded disease, but also ensure they have the option of continuing their service for our Country. We are aware of military personnel, including airman and shipman, that have had their military careers cut short by Lyme disease.

This DOD Program for tickborne disease research has been funded steadily at \$5M annually Fiscal Year 2016-2019, and was increased to \$7M in FY2020. During FY2016-18, 138 proposals were submitted for funding and 19 were funded. In FY 2019 alone, 62 proposals were received and 8 or just 13% were funded. We know more research could be funded and appreciate the modest increase this fiscal year to \$7M. We also know that to develop and commercialize just a single diagnostic can cost between \$50-75M, making CDMRP seed funding vitally important. Yet, it is clear far more Federal funding coupled with private funding is necessary to reach the goal of a reliable diagnostic. Diagnostics are the critical first step to developing a cure so that the researcher can accurately measure if his work is on target or needs adjustment.
