


# The Kay Hagan Tick Reauthorization Act (S.2398)

**Senator Susan Collins (R-ME), Senator Tina Smith (D-MN), Senator Angus King (I-ME)**

Tick-borne diseases such as Lyme, once considered a local or regional problem, have become an alarming national threat. The number of Americans with tick-borne diseases has been rising at a staggering rate over the past fifteen years. In 2003, Lyme disease infected around 30,000 Americans. The CDC estimates 476,000 new cases of Lyme each year, an astonishing 1,487 percent increase.

***Reported cases of Lyme disease are on the rise across the nation.  
Implementation of the National Strategy is needed now to end this growing crisis.***



## TICK Act Summary:

- **Require HHS to Implement the National Strategy to Prevent and Control Vector-Borne Diseases in People** to expand research, improve testing, and coordinate common efforts across the government. The strategy should also be updated as appropriate.
- **Reauthorize Funding for the Regional Centers of Excellence in Vector Borne Disease** for each of FY2026 - FY2030. These Centers collaborate with academia and public health agencies for surveillance, prevention, outbreak response.
- **Reauthorize Grants** to state health departments for five years to bolster their public health infrastructure for Lyme and other tick and vector borne diseases, and expand initiatives through public-private partnerships.
